<b>Who is entitled to enter the competition (Entry Requirements)?</b>	Entrants must be Australian residents
<b>Who is not allowed to enter the competition (the “Ineligible Entrants”)?</b>	<ul style="list-style-type: none"> <li>• Entrants aged under 18 years at the start date of the Competition Period</li> <li>• Employees and contractors of NAB and immediate family members of employees and contractors</li> <li>• Employees and contractors of the agencies or companies associated with the competition.</li> </ul>
<b>What is the applicable State or Territory (the “Applicable State/s”)?</b>	Australia-wide
<b>How does someone enter the competition (the “Entry Method”)?</b>	<ul style="list-style-type: none"> <li>• Match and screenshot right when the voucher hits the lines</li> <li>• Make sure you follow @nab on Instagram and like the post</li> <li>• DM @nab the screenshot and comment ‘won’ on the original post</li> </ul>
<b>When will the competition run (the “Competition Period”)?</b>	Friday 5 December – Wednesday 10 December inclusive
<b>How will the winner and runners up be chosen?</b>	<p>How the winner will be chosen:</p> <ul style="list-style-type: none"> <li>• The winner will be selected at random from all eligible entries. To ensure fairness, we will use a randomisation process in Microsoft Excel: <ul style="list-style-type: none"> <li>○ All Instagram usernames that commented “won” during the competition period will be compiled into a list.</li> <li>○ Each username will be assigned a random number using Excel's =RAND() function.</li> <li>○ The list will then be sorted by these random numbers.</li> <li>○ The username at the top of the sorted list will be declared the winner.</li> <li>○ The username will be validate to make sure they have met all entry requirements to be eligible for the prize before being declared the prize winner (follow @nab on Instagram, like the post, DM screenshot, commented ‘Won’)</li> </ul> </li> </ul>

<b>How are prizes to be claimed?</b>	Prize will be delivered to the winner via email as an electronic gift voucher.

<b>Is there a fee for entry?</b>	No fee for entry

<b>When is the unclaimed prize re-draw date (the “Unclaimed Draw Date”)?</b>	If the prize is unclaimed, we will redraw on Monday, 31 March 2026
<b>How many draws will there be (the “Number of Draws”)?</b>	There will only be one prize draw.
<b>What is the date, time and place of the draw (the “Draw Place, Date &amp; Time”)?</b>	The draw will take place at 9:30am on Thursday 11 December at NAB Place 395 Bourke St Melbourne
<b>What is the permit number?</b>	No permit is required for this promotion based on prize value.

### **Schedule of Conditions of Entry - Conditions of Entry**

1. These Conditions of Entry must be read together with the Schedule. By entering, entrants accept these conditions.
2. Entry is open to Australian residents who comply with the Entry Requirements (if any). Entries submitted by Ineligible Entrants are not accepted.
3. The competition will be run during the Competition Period.
4. Prizes and all elements of prizes must be taken as specified, as and when offered and cannot be altered or changed in any way by you or will be forfeited with no replacement. If you forfeit the prize or any element of the prize for whatever reason, you will not be given cash or any alternative prize as a substitute.
5. The prize value includes any applicable GST. You agree that if the Prize is unavailable for any reason, NAB may provide another item of equal or higher value, subject to any necessary approval by the state/territory gaming authorities.
